	Present Scenario of Legal Education:					
	In the post-Independence era Legal Education has been traditionally					



offered as a three years graduate degree. However the structure has been changed since 1987. Law degrees in India are granted and conferred in terms of Advocates Act 1961 and is a statute regulating the aspect of legal education and also regulation of the conduct of legal profession through Bar Council of India. Degrees in law are being offered by many Central, State and Private Universities. The establishment of National Law Universities in 1987, is considered as a major step towards reforming legal education in India. National law Schools are offering 5 years Integrated Course involving multidisciplinary approach after 12th standard. There are over 1500 Law Colleges, all over the country and 23 National Law Schools, besides the Law programs undertaken by various law colleges. In the State of Rajasthan, there are renowned Universities viz. Rajasthan, Ajmer, Udaipur and Bikaner University. NLU Jodhpur is offering BBA, LL.B. Degree since 2001.

Legal Education has become more practical and behavioral than just rote learning the letter of the law by introduction of Moot Courts. Publication of Journals, Internship and placement has become sine qua non part of Legal education.

Challenges: There is a huge difference in the way legal education is imparted at National Law Schools, Public State Universities and Private State Universities. Most of the public Universities/Institutions face various challenges and problems like lack of infrastructure, lack of permanent and regular faculty, lack of congenial work environment and most important among all, development of curriculum according to the present social, environmental and professional requirements.

In view of the above facts, given below is an action plan for consideration.

Action - Plan:

 This University is mandated to affiliate all the law colleges of the State of Rajasthan for which a comprehensive, synergetic framework ensuring fair, transparent and judicious affiliation process ensuring highest quality of legal education is needed.



- Besides the affiliation of law colleges, the University is required
 to develop a vision to attain and retain coveted position as a
 premier educational institution engaged in creation and
 dissemination of knowledge, ideas and methodologies in the
 field of legal education.
- In consonance of the above perspective, the University is contemplating to undertake the following academic programs/activities:-
 - (1) B.A. LL.B. (Hons) course with specialization in new and emerging areas like Mediation and Conciliation, Defense/Strategic Studies, Sports Law, Use and Regulation of Artificial Intelligence, Natural Resources and Energy Law & Petroleum Laws.
 - (2) LL.M. (2 years) with specialization in
 - (i) Cyber and Intellectual Property Laws
 - (ii) Constitutional and Media Laws
 - (iii) Corporate and Business Laws
 - (iv) International Laws
 - (3) Ph.D. in Law
 - (4) Diploma/Certificate Courses in:
 - (i) Cyber and Intellectual Property Laws
 - (ii) Labor and Industrial Laws
 - (iii) Mediation, Conciliation and Arbitration
 - (iv) Defense Studies.

As we are aware about the COVID-19 pandemic and several issues associated with this, and also the University being in the formative process experiencing certain logistical and financial issues, it is very crucial to decide the course of action particularly with regard to the feasibility of starting an academic session at the earliest.

- To coordinate and extend support to various departments in the university to organize online & offline teaching learning processes.
- To promote and also to undertake Consultancy/Contractual
 work relating to the use of computer facilities or developing
 software on payment basis for automation of workflow in the
 University.

To manage the affairs of the Computer Centre it is necessary to procure the following technical infrastructure like Desktop/PCs, Servers, Printers, Scanners, Software and referral material, Network Equipment, Peripherals and Preparation of site including AC, UPS, etc.

To establish the center the following technical staff is essentially required like One Senior Technical Officer, One System Analyst with adequate knowledge of server set up, One Programmer, One Technical Assistant with adequate knowledge of networking, One Technical Assistant with adequate knowledge of computer hardware and software, Four Multi-Tasking Staff (Computer Operator).

This is the minimum essential technical staff required to start the functioning of the Computer Centre; however, it will require expansion as per the need in future.

In the absence of the above facilities the automation of affiliation process, enrolment of students, examination and declaration of results would be a big task and the University will be compelled to outsource for fulfilling these requirements that would incur a significant cost to the University as compared to the cost of establishing the Computer

Since the ALU Act does not provide for such an Authority, it is recommended that the Planning and Development Board be established as an authority by the Board of Management of ALU, as per Rule 10(b)(vi); 43(a) and 44 of the ALU Act. Draft provisions pertaining to the proposed Planning and Development Board of ALU for the consideration of the Board of Management is as follows-

Planning and Development Board-

- (1) There shall be constituted by the Board of Management a Planning and Development Board which shall advise generally on the planning and development of the University and review the standards of education in the University.
- (2) The Planning and Development Board shall consist of the following members, namely-
- (a) The Vice Chancellor who shall be the ex-officio Chairman; and
- (b) Not more than five persons of high academic standing nominated by the Board of Management.
- (3) The Planning and Development Board shall have the right to advise the Board of Management and the Academic Council on any academic matter.
- (4) The term of office of the nominated members of the Planning and Development Board shall be two years and shall be eligible for renomination for another term.

Annual maintenance cost is Rs. 20000/- plus GST per annum. The service provider namely AVID Web Solutions Pvt. Ltd., Udaipur is providing the services to various other state universities as well. (Annexure - 13)

Agenda item No. 23

To consider the Budget of the University.

Brief facts and background

To meet the routine requirements and also to develop the university it is necessary to have adequate Budget for the University. In this regard the proposal of the Budget for FY 2020-21 demanding Rs.115.50 Lacs for Salary Head, and Rs.227.20 Lac for the Non-Salary Head and also Rs.330 Lacs for renovation, alteration, up gradation work and also for Furnishing and Civil work of the university has been submitted to the Government.

The University does not have any source of funding, other than the Government, until some funds are received through affiliation fees of the colleges. The efforts are being made for one time development grant from the Government.

Agenda item No. 24

To consider the engagement of a Consultant Academics for ten months at the consolidated amount of Rupees one lakh per month.

Brief facts and background

The University intends to formulate the academic programs of the university for which, to begin with, it is proposed to engage a senior academician as consultant academics to help the University; one who has relevant experience and can establish a law department in the newly established university. In this regard Prof. Mridul Shrivastav an eminent legal educationist, who superannuated from the University of Rajasthan has agreed to undertake the assignment.

To consider the engagement of Consultant IT for ten months at the rate of consolidated amount of Rupees Fifty Thousand per month.

Brief facts and background

The University recognizes the need to align its systems and infrastructure to improve on the efficiency of its operations, management and internal processes. As such, the University is embarking on a process to automate its functions by use of the state of art information technology tools and to get it implemented. To this end the University intends to engage a consultant, to design an efficient systems structure, then advice on the acquisition and deployment of solution through the agency hired by the University. Consultant shall also provide input, as and when required, for use of information and technology in the University and would also be involved in maintenance and operation of information technology system installed at the University including Wi-Fi and internet connectivity.

In this regard, the process of identifying the competent professional is under way.

Agenda item No.26

To consider authorization of the Vice-Chancellor for engagement and appointment of legal consultant and standing counsel/legal counsel for Rajasthan High Court, Hon'ble Supreme Court of India and other courts/forums/commissions as may be required.

Brief facts and Background

As the university has commenced its functioning, and taking various steps towards its development, requires legal vetting of various documents and consultation on various aspects in its day to day functioning, etc., there is a need to have a legal consultant with sound understanding of academic administration. The University also requires to appoint standing counsel/legal counsel for Rajasthan High Court and also at Hon'ble Supreme Court of India and other courts / forums / commission as may be required from time to time. The matter is placed before the Board for consideration and for authorizing the Vice Chancellor to take action for appointment of legal consultant and legal counsel/standing counsel for various courts and to fix their remuneration.

To consider the adoption of rules of University of Rajasthan with Agenda item No. 27 regard to TA/DA, Honorarium, Sitting Fee for various meetings and Over-time for various purposes. Brief facts and To undertake various activities and to make the provision for the background financial matter of the University, the University may adopt the rules of University of Rajasthan with regard to TA/DA, Honorarium, and Sitting Fee for various meetings, rates for over-time working and all such purposes. To consider INNOVA car for the Vice Chancellor with driver and Agenda item No. 28 other car for other officers like Registrar, Comptroller of Finance and Controller of Examination for Examination/ Research/ Academics. INNOVA is the most preferred vehicle which is used by all the Vice-Brief facts and background Chancellors of the state universities. The Vice-Chancellor shall be entitled to use INNOVA Car for official purposes. After assuming office, on 2nd March 2020, considering an immediate need, an INNOVA car has been hired, from Samarthan travels, Jaipur at the rate of Rs. 50000 per month. The same shall be continued and all formal procedures will be followed for regular maintenance and continuity of the same. The Vice-Chancellor shall also be eligible to use the University vehicle for private purposes and pay the charges as are prescribed by the Government for private use of Government vehicle by officers on the basis of kilometers involved, for private use. A full time vehicle driver is essential for smooth and punctual discharge of duties by the Vice -Chancellor and vehicle maintenance. Accordingly the University may be allowed to purchase/hire one INNOVA car for the Vice-Chancellor, one INNOVA for office use and three Ciaz cars for the use of Registrar, Comptroller of Finance and Controller of Examination respectively. It is pertinent to mention here that the Campus of the university is located about 26 KM, away from the town and also that the entire

state is its Jurisdiction.

In view of the aforesaid transitory provisions, it is hereby notified that until Statutes, Ordinances, Regulations, Notices, Orders made or issued by the competent authority of University of Rajasthan is modified/substituted/superseded by appropriate Statutes, Ordinances, Regulations, Notices or Orders made or issued by competent authority of Dr. Bhimrao Ambedkar Law University, Jaipur, the provisions contained in Statutes, Ordinances, Regulations, Notices, Orders made or issued by the competent authority of University of Rajasthan shall govern the affairs of Dr. Bhimrao Ambedkar Law University, Jaipur and during the transitory period, all officials shall discharge their duties and take action accordingly.

With reference to your letter No. DBALU/2020/VCSEC/06 dated 17.03.2020 on the above subject, I am directed to say that **Dr. Bhimrao Ambedkar Law University**, **Jaipur**, **Rajasthan** has been established by an act of the State Legislature of **Rajasthan** as a State University Act 6 of 2019 vide Notification No. F.2(9) Vidhi/2/2019 dated 26th February, 2019 and is empowered to award degrees as specified by the UGC under section 22 of the UGC Act 1956 at its own departments, its constituent colleges and/or through its affiliated colleges in regular mode with the approval of concerned statutory bodies/councils, wherever required.

The University shall operate only within the territorial jurisdiction allotted to it under its Act and in no case beyond the territory of the State of its location. The University is not allowed to start any off-campus centre beyond the territorial jurisdiction as provided in the Act and under no circumstances beyond the State of its location, as per the Hon'ble Supreme Court Judgment in Prof. Yash Pal vs. State of Chhattisgarh case.

The University may note and adhere to the following: -

- (i) To ensure that no off campus centre(s)/study centre(s) is opened beyond the territorial jurisdiction of the University as stipulated in the Act and in no case beyond the territory of the State.
- (ii) To ensure that no programmes should be offered through franchising arrangement with private institutions.
- (iii) To ensure that no study centre(s) are opened through franchises by the University.
- (iv) In case the university has already started any off-campus/study centre and the centre operating through franchises outside the State, it must be closed immediately.

- (v) No distance education programmes shall be started without the prior approval of UGC.
- (vi) M.Phil/Ph.D programmes can be conducted as per the provisions of UGC (Minimum Standards and Procedure for Awards of M.Phil/Ph.D. Degree) Regulations, 2016.
- (vii) The University is required to follow all the UGC Regulations notified and available on UGC website www.ugc.ac.in.

At the outset, the Vice-Chancellor, Dr. Bhimrao Ambedkar Law University welcomed all the Hon'ble Members and presented floral bouquet to the members. Thereafter, the Vice-Chancellor presented the following brief account of the details of activities of the University from its inception till date:-

- Dr. Bhimrao Ambedkar Law University was established by the State Government of Rajasthan, by enacting "Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019 (Act No.6 of 2019), which received the assent of Hon'ble Governor on 26th February, 2019. Thereafter, the State Government by its Notification No. F.2(9)vidhi/2/2019 dated 26.02.2019 issued the notification of the University.
- The Chancellor, after consultation with the Government of Rajasthan, in exercise of his powers conferred under Section 11 (17) of Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019, appointed Dr. Dev Swarup as first Vice-Chancellor of

the University on 27th February 2020 for a period of three years. He joined as its founder Vice-Chancellor on 2nd March, 2020.

- The Vice-Chancellor vide his letter dated 06th March, 2020 formally informed the Bar Council of India about the establishment of the University & its objects and endeavour.
- The Secretary, Higher Education, the Vice-Chancellor and the Registrar collectively launched the Website of the University (www.alujaipur.ac.in) on 22nd April, 2020 digitally, In spite of Lockdown due to Covid-19, it has been visited 48,000 times so far.
- The Vice-Chancellor vide his letter dated 17th March, 2020, formally requested the University Grants Commission, New Delhi for inclusion of the University under Section 2 (f) of UGC Act. The University Grants Commission vide its letter dated 12th & 14th May, 2020 issued the notification with regard to inclusion of Dr.Bhimrao Ambedkar Law University, Jaipur under Section 2(f) of UGC Act 1956.
- The Vice-Chancellor formulated the Vision & Mission of the University reflecting the purpose and perspective. It has been duly uploaded on the Website of the University.
- The Vice-Chancellor vide his letter dated 18th April, 2020 requested the Government to provide temporary building/campus for the University to undertake various activities of the University. The Government as an interim arrangement has allotted the city camp office of the University at RUSA Block, Ground Floor, Shiksha Sankul, Jaipur vide letter dated 24th June, 2020.
- The Vice-Chancellor vide his letter dated 18th April, 2020 requested the Government for allocation of permanent campus of the University. The Government vide its letter dated 22nd July, 2020 authorized the University to have right to use for land, infrastructure and the resources available at Ambedkar Peeth, Mundla, Jamwaramgrah, Jaipur.
- A Cabinet decision has been taken on 2nd September, 2020 for making it as a permanent campus. Accordingly a master plan will be prepared for the proper development of the campus, its landscaping and also to have required infrastructure in a phased manner.
- The Vice-Chancellor vide his letter dated 22nd April, 2020 informed the Government about the provision in the Act with regard to affiliation of all law colleges. The Government vide its order dated 22nd July, 2020 notified that all law colleges of the state, except the constituent colleges of other Universities shall be affiliated to the Dr. Bhimrao Ambedkar Law University Jaipur from the academic Session 2020-21. There are 88 Law Colleges spread across the state.
- The Vice-Chancellor vide his letter dated 27th July 2020 addressed to the respective Vice-Chancellors, requested for adherence to the Government order dated 22nd July, 2020 with regard to affiliation of Law Colleges in letter & spirit.
