<b>Agenda</b>	<b>To consider the procedure for preparation of panel of Subject Experts for Selection Committees for the teaching posts in the University.</b>
<b>Brief facts and background</b>	<p>Section 50 of the University Act lays down the following provisions:</p> <p>“(1)All Statutes, Ordinances and Regulations made under the University of Rajasthan Act, 1946 shall, in so far as they are not inconsistent with the provisions of this Act, be deemed to have been made under this Act and shall continue to be in force until they are superseded or modified by the Statutes, Ordinances or Regulations made under this Act.</p> <p>(2)All notices and orders, made or issued by any authority under the University of Rajasthan Act, 1946 shall, in so far as they are not inconsistent with the provisions of this Act, be deemed to have been made or issued by the corresponding authority under this Act and shall continue to be in force until they are superseded or modified under this Act.”</p> <p>In pursuance of the aforementioned provisions, it is to be construed that the University is required to adhere to the systems and procedures being followed by the University of Rajasthan for various academic and administrative decision making purposes. However, it is also pertinent to bring on record that the University being in its formative stage does not have the same academic and administrative setup in place as that of the University of Rajasthan, such as Departments, Board of Studies, Academic Council etc. except the Board of Management which is similar to the “Syndicate” of the University of Rajasthan. Hence, in the absence of similar academic set up it is not possible for the university, at this stage, to follow the same procedure in all the matters, till these bodies are constituted.</p> <p>The University, in view of the decision taken in its BoM meeting dated 12th September, 2020 is in the process of</p>



commencing its academic activities with LL.M. one year program from the session 2020-21 itself. Therefore, in order to meet the academic requirements, it is imminent to make the regular selection/appointments for the posts sanctioned by the State Government at the earliest.

To undertake the task of selecting/appointing the faculty, the first and foremost requirement is the Panel of Experts duly finalized by Rajasthan Public Service Commission (RPSC) for forming the Selection Committees. For this, the standard practice being followed by University of Rajasthan is that the panel of subject-wise names is prepared by the university by involving BoS, Academic Council and Syndicate and the same is sent to the RPSC. The RPSC, after due consideration, finalizes the subject experts and sends it to the university. These subject experts are used for forming selection committees in various subjects.

Dr. Bhimrao Ambedkar Law University being a newly established university, is yet to have the above mentioned set up. Hence, the university is neither in a position to follow the same procedure as being followed at the University of Rajasthan for preparation of the panel of subject experts, nor can the university await for the constitution and formation of statutory bodies of university like Departments, Board of Studies, Academic Council etc. as it may take time.

In the present scenario, to address this issue, the following procedure is being proposed to be adopted ;

“The University shall prepare a list of some professors of law, as subject experts for consideration by the Board of Management, which will then shortlist/approve those names on behalf of the university. The names approved by BoM will then be sent to the RPSC for finalization of the panel of subject experts in law for the University. The duly approved Panel of experts finalized by RPSC will be used for various Selection Committees of the university.”

<b>To consider the procedure for preparation of Panel of Subject Experts for Selection Committees for the Teaching Posts in the University.</b>	<p>The Board of Management in its meeting held on 12.09.2020 decided to commence the academic activities of the University which includes the commencement of one year LL.M. programme from the present academic session 2020-21 itself. Pursuant to the aforesaid decision of the BoM and in order to meet the academic requirements, it became imperative and essential to make regular selection / appointments to the posts sanctioned by the State Government at the earliest. It needs to be taken into consideration that it is a newly established University, does not have the statutory bodies like Departments, Board of Studies, Academic Council etc. hence, it is unable to follow the same procedure as being followed by the University of Rajasthan.</p> <p>Therefore, keeping in view the aforesaid facts and circumstances and the immediate requirements of the university which are essential for commencing the educational activities, teaching learning processes and the</p>

LL.M. course and also the views put forth by Members expressing their consent/agreement/approval of the proposal contained in the agenda (which was circulated by email), the following procedure is approved to be adopted for undertaking the process of preparation of Panel of Subject Experts, till the prescribed mechanism for such purposes, is put in place.

**“The University shall prepare a list of Professors of Law, as Subject Experts for consideration by the Board of Management, which will then shortlist / approve those names on behalf of the university. The names approved by BoM will then be sent to the Rajasthan Public Service Commission (RPSC) for finalization of the Panel of Subject Experts in Law for the University. The duly approved Panel of experts finalized by RPSC will then be used for Selection Committees of the University, for selection of faculty.”**
