<p>Agenda item No. 2</p> <p>Brief facts and background</p>	<p>To report about the nomination of Dean, Faculty of Law for the University.</p> <p>Section 50 of Dr.BhimraoAmbedkar Law University, Jaipur Act, 2019 (Act No.6 of 2019), provides the transitory provisions that All Statutes, Ordinances and Regulations made under the University of Rajasthan Act, 1946 shall, in so far as they are not inconsistent with the provisions of this Act, be deemed to have been made under this Act and shall continue to be in force until they are superseded or modified by the Statutes, Ordinances or Regulations made under this Act. Brief facts and background	<p>In view of the order no. 15 (5) education-4/2020 dated 22nd July, 2020 of the Government of Rajasthan with regard to extending affiliation to all the Law Colleges of the State of Rajasthan except the constituent colleges of other Universities, the process was undertaken and as decided by BoM, in all such cases where the documents were received from the respective Universities with regard to fitness for the affiliation by those Universities, the Deemed to be Affiliation letters were issued. (Copy enclosed) • Application proforma to be supported by requisite documents. • An affidavit to be taken from the Principal/Secretary of the society/trust of the college to the effect that the information provided in the proforma is correct and if found incorrect will be liable for appropriate action against the college.(Copy enclosed) • The prescribed fee etc to be charged as per the fee structure approved by the Finance Committee of the University. • The processing of the proposal by the University administration. • The Committee(s) constituted by the Vice-Chancellor to inspect/visit the college online and to submit its report with specific observations whether fit to extend its affiliation for one or more sessions or otherwise. • The decision to be taken by Vice-Chancellor on the basis of the report(s). • No provision of appeal if found unfit for extending affiliation. • The process of affiliation to be completed in a time bound manner by the end of July 2021. <p>The proposals received may be processed by the University administration and in order to assess their fitness, the committee(s) constituted by the Vice-Chancellor may inspect/visit the college online.</p> <p>The same is being proposed keeping in view the concern expressed by BCI on various occasions and to administer the affiliation process by the University in a professional manner and time bound manner.</p> <p style="text-align: right;">(Annexure –8 &8A)</p>





The BoM noted that, in view of the fact that the university does not have a permanent campus and is operating from its temporary office at Shiksha Sankul, J.L.N. Marg, Jaipur, the construction of Constitution Park ,pillar and the University Park would be taken up in due course after permanent campus of the university is established and sufficient resources including technical manpower is in place, as technical know how is needed for planning the University park at Raj Bhawan too.

2	To report the approval of the Government with regard to sanction/approval of the Teaching & Non-teaching posts for the University.	<p>The Government has sanctioned 26 Non-teaching posts vide its letter प.15(2) शिक्षा-4/2019 dated 05.11.2020. The government has also sanctioned teaching posts of 05 Professors, 10 Associate Professors and 20 Assistant professors vide its communication no. प.15(2) शिक्षा-4/2019 dated 06.01.2021. While undertaking the process of appointment for teaching posts, efforts are in progress to get more Non-teaching posts for the University.</p> <p>This was noted and highly appreciated by the BoM with thanks to the Department of Higher Education and Department of Finance, Government of Rajasthan.</p>
3	To report the approval of the Government for the Purchase of one Ciaz Car for the Vice-Chancellor.	<p>The Government has sanctioned one Ciaz car vide letter no. प.15(1) शिक्षा-4/2019 dated 05.01.2021 for the use of Hon'ble Vice Chancellor of the University. Due to expansion of the University, now, more vehicles are required, to execute administrative and academic activities. In this regard, efforts are in progress for sanction of more vehicles to the University. This was noted by the BoM with thanks to the Department of Higher Education and Department of Finance, Government of Rajasthan.</p>






Brief facts and background	<p>The University after coming into existence has started various academic and administrative activities including commencement of the academic Session 2020-21 with LL.M. Programme of one year. In order to make the university go ahead with its academic activities and regular classes the Government has sanctioned 35 faculty positions, Professor-05, Associate Professors-10, Assistant Professors-20 vide its letter no. प.15(2)शिक्षा-4/2019 dated 06-02-2021.</p> <p>The Section 50 of the University Act lays down the following provisions:</p> <p>“(1) All Statutes, Ordinances and Regulations made under the University of Rajasthan Act, 1946 shall, in so far as they are not inconsistent with the provisions of this Act, be deemed to have been made under this Act and shall continue to be in force until they are superseded or modified by the Statutes, Ordinances or Regulations made under this Act.</p>

(2) All notices and orders, made or issued by any authority under the University of Rajasthan Act, 1946 shall, in so far as they are not inconsistent with the provisions of this Act, be deemed to have been made or issued by the corresponding authority under this Act and shall continue to be in force until they are superseded or modified under this Act.”

In pursuance of the aforementioned provisions, it is to be construed that the University is required to adhere to the systems and procedures being followed by the University of Rajasthan for various academic and administrative decision making purposes.

However, considering the fact that the University is in its formative stage and does not have the same academic and administrative setup in place as that of the University of Rajasthan, such as Departments, Board of Studies, Academic Council etc. except the Board of Management which is similar to the “Syndicate” of the University of Rajasthan, it was felt that, at that stage it was not possible to follow the same procedure in all the matters, till these bodies are constituted.

The University in its meeting of BoM dated 12th September, 2020 decided to commence the Academic Session one year program LL.M. from the session 2020-21 itself and it was also decided to make the regular selection/appointments for the posts sanctioned by the State Government at the earliest to meet the academic requirements of the University.

To undertake the task of selecting/appointing the faculty, the first and foremost requirement is the Panel of Experts duly finalized by Rajasthan Public Service Commission (RPSC) for forming the Selection Committees. For this, considering the circumstances, as decided by BoM, in place of the standard practice being followed by University of Rajasthan involving BoS, Academic Council and Syndicate, to send the names of the Professors subject wise to RPSC. In the present case, in the absence of Academic Council, as decided by the BoM of the University a list of 44 Professors of Law listed below was prepared, which was duly considered by BoM and after its approval the same was sent to RPSC for finalization of the Panel of Experts in Law for the University.

In this regard, the Committee constituted under the Chairmanship of Dr.S.S. Rathore, Member RPSC along with two other members had a meeting on 22nd February, 2021, and have resolved as follows:

"The members deliberated the issue under consideration in view of Section 29 of Dr. Bhimrao Ambedkar Law University, Jaipur Act (Act No.6 of 2019).

"Teachers and Officers of the University:

"(1) The appointment of teachers and Officers of the University shall be made in accordance with provision of the Rajasthan Universities Teachers and Officers (Selection for Appointment) Act, 1974 (Act No. 18 of 1974)."

Therefore selections are to be held as per modality and procedure given under the Rajasthan Universities Teachers and Officers (Selection for Appointment) Act No.18 of 1974 as per section 12:-

"Act to have over-riding effect

- (1) The provision of this Act shall have effect notwithstanding anything contained in the relevant law.
- (2) So much of the relevant law as provides for the matters covered by this Act shall, as from the commencement of this Act, cease to have effect as respects those matters."

And as per Explanation II of the schedule I of the said Act 1974:-

".....said committee shall from out of the panel of names recommended by the Academic Council recommend to the Vice-Chancellor of the University concerned names of at least twelve experts for each selection committee which shall be in order of priority."

Since the panel of experts for selections has been recommended by the board of management in place of Academic Council which is not acceptable under section 12 of the Rajasthan Universities' Teachers and Officers (Selection for Appointment) act No.18 of 1974 and above explanation.

Hence, we are of the view that the panel of experts be prepared by the Academic Council and be recommended along with the minutes to this committee for doing the needful."

In view of this it is for consideration by the Academic Council to take a view and finalize the list of professors of law to be sent to RPSC.

Undergraduate :

- (i) B.A.LL.B. (Five years), (Integrated course) (Semester Scheme)
- (ii) BBA. LL.B. (Five years), (Integrated course) (Semester Scheme)
- (iii) LL.B. (Three Years Course), (Yearly)

Postgraduate:

- (iv) LL.M. (One Year Course), (Semester Scheme) For on Campus/University Students.
- (v) LL.M. (Two Years) (Annual Scheme) For All Affiliated Law Colleges.

Diploma :

- (vi) One year Diploma in Labour Laws (Annual Scheme)
- (vii) One year Diploma in Forensic Science (Annual Scheme)
- (viii) One year Diploma in Criminology (Annual Scheme)


The same was presented before the BoM of the University in its meeting held on 30th January, 2021 and the BoM approved the same.

The LL.M one year programme of the university is ongoing with the above syllabus approved by BoM.

The uniform syllabus for all the above mentioned courses is presented to the Academic Council for its consideration.



At the outset, the Vice-Chancellor, Dr. Bhimrao Ambedkar Law University while welcoming the Hon'ble Members also explained the reasons and justification for convening the special meeting of Academic Council and specifically mentioned the need to seek advice of Academic Council on various academic matters of the University, the University being in its formative stages.


The Vice-Chancellor presented the following brief account of the details of activities of the University from its inception till date:-

- Dr. Bhimrao Ambedkar Law University was established by the State Government of Rajasthan, by enacting "Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019 (Act No.6 of 2019), which received the assent of Hon'ble Governor on 26th February, 2019. Thereafter, the State Government by its Notification No. F.2(9)vidhi/2/2019 dated 26.02.2019 issued the notification of the University.
- The Chancellor, after consultation with the Government of Rajasthan, in exercise of his powers conferred under Section 11 (17) of Dr. Bhimrao Ambedkar Law University, Jaipur Act, 2019, appointed Dr. Dev Swarup as first Vice-Chancellor of the University on 27th February 2020 for a period of three years. He joined as its founder Vice-Chancellor on 2nd March, 2020.





- The Vice-Chancellor vide his letter dated 06th March, 2020 formally informed the Bar Council of India about the establishment of the University and its objectives and endeavours.
- The Secretary, Higher Education, the Vice-Chancellor and the Registrar collectively launched the Website of the University (www.alujaipur.ac.in) on 22nd April, 2020 digitally, in spite of Lockdown due to Covid-19, it has been visited 2 lac times so far.
- The Vice-Chancellor vide his letter dated 17th March, 2020, formally requested the University Grants Commission, New Delhi for inclusion of the University under Section 2 (f) of UGC Act. The University Grants Commission vide its letter dated 12th & 14th May, 2020 issued the notification with regard to inclusion of Dr. Bhimrao Ambedkar Law University, Jaipur under Section 2(f) of UGC Act 1956.
- The Vision & Mission of the University reflecting the purpose and perspective was duly approved by the BoM of the University and has been uploaded on the Website of the University.
- The Vice-Chancellor vide his letter dated 18th April, 2020 requested the Government to provide temporary building/campus for the University to undertake various activities of the University. The Government as an interim arrangement has allotted the city camp office of the University at RUSA Block, Ground Floor, Shiksha Sankul, Jaipur vide letter dated 24th June, 2020.
- The Vice-Chancellor vide his letter dated 18th April, 2020 requested the Government for allocation of permanent campus of the University. It is hoped that the university will get suitable and adequate land for the permanent campus of the university soon.
- The Government vide its order dated 22nd July, 2020 notified that all law colleges of the State, except the constituent colleges of other Universities shall be affiliated to the Dr. Bhimrao Ambedkar Law University Jaipur from the academic Session 2020-21. There are 88 Law Colleges spread across the state. The same is being pursued.





- The Vice-Chancellor vide his letter dated 27th July, 2020 informed the Chairman, Bar Council of India about the office order issued by Govt. of Rajasthan on 22nd July, 2020, with regard to affiliation of all law colleges of the state except constituent colleges of other Universities, to Dr. Bhimrao Ambedkar Law University, Jaipur from the academic session 2020-21.
- The Vice-Chancellor issued an office order on 14th August, 2020 regarding due discharge of the duties during the transitory period, referring to Section - 50 (1) & (2) of the Act.
- The State Government has sanctioned 35 Faculty Positions i.e. 05 Professors, 10 Associate Professors, 20 Assistant Professors for the University.
- The University has commenced the Academic Session 2020-21 with LL.M. one year programme with intake of 40 students and the classes are being taken by the teaching faculty of Department of Law of University of Rajasthan, as Guest faculty. The Government has increased the Honorarium from Rs.500/- to Rs.1000/- per class for the University.
- The University has finalised its Logo through a Competitive Process and it was duly released by the Hon'ble Chief Minister of Rajasthan on 26th February, 2021 and finally adopted by the University.
- The University has got the Membership of AIU vide its letter No. AIU/Meet/GC/361(a)/2021 dated 03rd March, 2021.

The members complimented the Vice-Chancellor for his consistent efforts in taking the university forward.

Thereafter, the Registrar of the University as Member Secretary of Academic Council explained the functions of the Academic Council of the University and also the composition of the Academic Council. While explaining, it was specifically mentioned that the Law University is a single faculty institution which deals only with law whereas University of Rajasthan is a multi faculty institution dealing with several faculties. It was also brought on record that the University being recently established does not have any department, and teaching faculty is yet to be recruited. The colleges are in the process of affiliation and as such the university does not have the Board of Studies. Further, it was also categorically mentioned that the Quorum requirement according to size of Academic Council of the University of Rajasthan approximates to around 1/3rd of

the total members as per statutes of the University of Rajasthan. Since, Dr. Bhimrao Ambedkar Law University Act 2019 does not contain any such quorum stipulation, therefore keeping in view section 50 of the Act of 2019, taking external aid, it can be concluded that considering the total number constituting the Academic Council of Dr. Bhimrao Ambedkar Law University, and in accordance with Section 22 of the Act of 2019, the Members present in the meeting fulfil the statutory requirement of the Act of 2019 to hold this meeting and also other relevant provisions pertaining to the quorum.

Accordingly, on concurrence of the members of Academic Council present in the meeting, the Agenda (s) was presented by the Registrar.

It was also noted that the Committee constituted under the Chairmanship of Dr.S.S. Rathore, Member RPSC along with two other members had a meeting on 22nd February, 2021, and have resolved as follows:

"The members deliberated the issue under consideration in view of Section 29 of Dr. Bhimrao Ambedkar Law University, Jaipur Act (Act No.6 of 2019).

"Teachers and Officers of the University:

"(1) The appointment of teachers and Officers of the University shall be made in accordance with provision of the Rajasthan Universities Teachers and Officers (Selection for Appointment) Act, 1974 (Act No. 18 of 1974)."

Therefore selections are to be held as per modality and procedure given under the Rajasthan Universities Teachers and Officers (Selection for Appointment) Act No.18 of 1974 as per section 12:-

"Act to have over-riding effect

- (1) The provision of this Act shall have effect notwithstanding anything contained in the relevant law.**
- (2) So much of the relevant law as provides for the matters covered by this Act shall, as from the commencement of this Act, cease to have effect as respects those matters."**

And as per Explanation II of the schedule I of the said Act 1974:-

".....said committee shall from out of the panel of names recommended by the Academic Council recommend to the Vice-Chancellor of the University concerned names of at least twelve experts for each selection committee which shall be in order of priority."

Since the panel of experts for selections has been recommended by the board of management in place of Academic Council which is not acceptable under section 12 of the Rajasthan Universities' Teachers and Officers (Selection for Appointment) act No.18 of 1974 ,hence the above explanation.

Hence it was opined that the panel of experts be prepared by the Academic Council and be recommended along with the minutes to this committee for doing the needful."

In this regard, after considering the facts and circumstances the Academic Council of the University recommends the following Panel of Experts in Law for consideration and finalization of Panel of Experts in Law by RPSC for Dr.Bhimrao Ambedkar Law University for selection of faculty

2. The LESSEE agrees that the obligations may continue throughout the term hereby granted with the LESSOR in the manner following that is to say :-





The Bar Council of India received and is still receiving thousands of letters and requests from the students of different Universities and law colleges of the country. Some heads of Institutions have sought guidance of the Council on the point of examinations and promotions of LL.B. Students.

The concern of majority of students was to grant them promotions on the basis of past performance or through some other method of assessment.

The students have expressed their grievances and assigned different sorts of reason for issuance of a general direction to all the Centers of Legal Education restraining them from holding any online or offline examination of any semester.

Even many final year LL.B. students have raised similar grievances and their demands are also of the same nature.

The Council vide its resolutions dated 29.05.2021 thoroughly discussed and deliberated over the issue. The related Judgments of Hon'ble Apex Court in Writ Petition (Civil) No.724/2020 titled as Praneeth K and Ors. versus University Grants Commission and Ors. and the Division Bench Judgment of Karnataka High Court was also perused by the Council.

In fact, the Bar Council of India in its resolution dated 29.05.2021 had clearly expressed its views that it does not wish to involve itself in the matters of examinations and it is for the Universities to take their own decisions depending on the local conditions. Of course, the Bar Council of India's concern is to maintain the standard of Legal Education and the Bar Council of India cannot compromise with the standard.

At the same time, the problems of students and Institutions was/is also to be taken care of by the Bar Council of India.

Since, the Council is the regulator of Legal Education and every student (particularly the students belonging to remote areas) is not supposed/cannot afford to move the Law Courts, therefore, the Bar Council of India had constituted a High Level Committee of Expert to consider the issue in details and to submit its report, so that the Council could take a final decision in the matter and could place its views before Hon'ble Delhi High Court and/or other Courts as and when necessary.

The proceedings and report of the Committee dated 08.06.2021 headed by Hon'ble Mr. Justice Govind Mathur, former Chief Justice of Allahabad High Court is reproduced herewith: -

Report Quoted: -

"Report of the High Level Expert Committee of the Bar Council of India to discuss and deliberate upon the issue of mode of intermediate semester examination/evaluation and promotion of intermediate LL.B students AND also to consider evaluation of the mode of examination before issuance of degree for Final year Law students, in view of the unprecedented situation arising due to the pandemic, held on 6th June, 2021 at 11.00 am through Video-Conferencing.

"The Members deliberated at length regarding the mode of evaluation/examination for the promotion from intermediate semester to the next semester and for the award of the Law Degree.

After detailed discussion and deliberations, the Committee unanimously agreed that each University/Centers of Legal Education shall conduct examination for intermediate and final year students, as per their own dispensation, depending upon the availability of resources and the impact of COVID 19 in that region. It was unanimously agreed that an end-term examination is mandatory to be conducted by all Law Schools/Universities. It was further decided that University/Centers of Legal Education are free to determine the mode of examination [Online/Offline/Blended/Online Open Book Exam (OBE)/ Assignment Based Evaluation (ABE)/Research papers].


The Committee also recommended that the Universities/Centers of Legal Education should ensure that sufficient time gap exists between regular and backlog examinations to avoid inconvenience to the students.

The Committee also took note of the earlier resolutions adopted by Bar Council of India on 27.05.2020, 06.09.2020, 05.10.2020 and 01.11.2020 which had stipulated examinations for all semesters, and wherein guidelines regarding the mode of conduct of examination/evaluation had been issued, and unanimously agreed that the University/Centers of Legal Education are free to determine the mode of evaluation/examination for promotion and for award of the Law Degree and for the conduct of examination.


The meeting ended with a vote of thanks to the Chair."



The issue was deliberated upon and it was agreed that the colleges which have been extended Deemed to be Affiliated on the basis of reports of respective universities, need to be accepted by this university as a final document for affiliation purposes for the academic session 2020-21. Accordingly, the colleges may be issued a letter of affiliation for the session 2020-21 in place of Deemed to be affiliated.

Decision will be taken on the basis of report of the Committee, however, in case of certain deficiencies the college may be considered for affiliation for the session 2021-22 with a condition that the deficiencies will be addressed and compliance made within 6 months, failing which the college will not be considered for affiliation for subsequent sessions.

5. In case of the colleges already granted permanent affiliation by the earlier respective Universities, that will be accepted and continued as such. However, a review will be undertaken by this University to reassure that the college fulfils the required criteria of affiliation. And the Universities which have granted them permanent affiliation be requested to transfer the affiliation fee paid by such colleges to this University.
6. In case a college is recommended by the committee for its affiliation for more than one academic session, physical verification of the college needs to be undertaken by a committee constituted by the Vice-Chancellor for the purpose, and the decision with regard to extending affiliation should be taken on the basis of its report.
7. While constituting the committee for the visits of such colleges, the members of BoM other than those who are principals of Law Colleges, may also be part of the committee if they could be available.
8. Strict monitoring of the colleges will be carried out on a regular basis to meet the academic standards. In case, any college fails to meet the academic standards and thus invites stern action which may lead to de-affiliation also, the responsibility of the students will rest with the college alone.
9. The process of affiliation for the session 2021-22 needs to be completed within the next two months.
