

**REVISED MODE FOR CONDUCTING THE B.A. LL.B. / B.B.A. LL.B. FIRST  
SEMESTER EXAMINATION (FIVE YEARS INTEGRATED COURSE) FOR THE  
SESSION 2020-21 ONLY**

There are five papers in B.A. LL.B. / B.B.A. LL.B. First semester examination (Five Years integrated course)

Each paper in the semester carries maximum 100 marks. The scheme of evaluation and marking of 100 marks has already been divided in two parts-

(A) 70 marks for written examination

(B) 30 Marks for internal assessment (marks of internal assessment has already been reasonably classified in three parts for evaluation) in the syllabus out of which evaluation of 15 marks (10 marks for project and 5 marks for viva voce) shall be done by the external examiner appointed by the University.

**Relating to 70 Marks of written paper:**

There shall be five assignments in each subject one from the each unit of the paper.

All assignments carry equal Marks (Each of 14 Marks)

1. The examinee is required to attempt these all five (5) assignments and to submit the same within three (3) days from the date on which the assignments are given to him by the respective College.
2. Assignments in each subject shall contain topics / critical notes / leading cases given by the examiner appointed by the university.
3. The examinee has to prepare hand written assignments in not more than twenty (20) Pages on A4 size paper in spiral binding.
4. There shall be a prescribed proforma for cover page (Form -A). The candidate is required to fill up all the particulars in it, without which it cannot be submitted in the college.
5. The examinee shall enclose an undertaking duly signed by him (Form - B).
6. The college shall collect the assignment from the examinee within the stipulated time provided by the University for further transmission to the Controller of Examination of this university as per the directions issued by the University.
7. The college must ensure that all the particulars in the prescribed proforma submitted by the candidate are complete and correct. Same must be verified and duly signed by the principal of the concerned college.

8. All the rules relating to the examinations shall be applied on both the examinee and the college.
9. All the proforma relating to examination required by the university shall be returned duly completed and verified by the college with in the stipulated time given by the university.
10. Evaluation of the assignments shall be made by the university as per the rules of the examination.
11. There shall be no revaluation of the script submitted by the candidate
12. The candidate who obtains minimum 36% marks in each paper individually and 48% marks in aggregate in at least three papers including Part-B i.e. practical paper(s) in semester I Examination for session 2020-2021 of B.A.LL.B. / B.B.A.LL.B. (Five Years Integrated course) shall be eligible to re-appear in not more than two papers (theory and practical both) in the following examination under the examination scheme in force at that time provided by the university.
13. The candidate who fails or could not take the examination for the session 2020-21 shall have to appear in all the papers only in the following examination.
14. Proforma A and B shall be completed, failing which the script submitted by the candidate shall not be entertained for evaluation.
