- 2. The Cost of online affiliation form will be Rs. 1,000/- per affiliation form.
- The Colleges applying for affiliation are required to pay Inspection fee of Rs. 25,000/- per affiliation form
- 4. The hard copies of the form and documents to be deposited by the college in the Academic-II Section of the University within seven days from the expiry of date of online affiliation form given by the University. Failing which Rs. 500/- per day will be charged from the concerned college that too upto 06.02.2022.
- The procedure has been devised, considering the affiliation rules being followed at University of Rajasthan, Jaipur. However, if need more details may be sought from the colleges.
- The existing Colleges will be required to fill up AISHE code provided by the MHRD and NAAC certification by the UGC.
- The college will carefully choose the category of affiliation i.e. Fresh/Extension/Increase Intake/Additional Subject/Permanent otherwise neither the category will be changed nor the fee will be returned/adjusted.
