Note: In addition to above following fee shall also be applicable-

- (i) Enrollment Fee : Rs. 450/-, Eligibility Fee : Rs. 450/- . This fee shall be charged with 1st Year/Part-I/P.G. Diploma Examination Forms only.
- (ii) Degree Fee - LL.B. Course & PG Diploma Course Rs. 240/-, LL.M. Course Rs.600/-. This Fee shall be charged with final year Exam. forms only.
- (iii) If candidate opts for improvement paper(s)/ subject(s) as per applicable rules for securing pass percentage, he/she should be charged fee equal to due paper(s)/subject(s) fee for such improvement.
- (iv) If LL.B. candidate appearing in Due / Improvement paper(s) but not appearing in examination of higher class, then he/she should be charged Rs.1200/- as Examination Fee of Final Year alongwith Fee for Due/ Improvement Paper(s) of lower class as per Sr. No.4 of the table, as the case may be.

The detailed instructions as mentioned in earlier notification dated 21.05.2026 and 06.06.2026 shall remain same and all candidates and Principal of the College/ College Staff should follow the same.

Colleges are compulsorily required to update all such filled exam forms, who are eligible to appear in ensuing exam at online college panel of the University and ensure to submit hard copy along with the requisite documents at University office latest by 30.06.2026. After passing the last date of exam. form online approval and submission of hard copy of exam forms at University office, will not be accepted and such candidate (s) may not be permitted to appear in concerned examination. Kindly ensure the timeline and concerned college and candidate will be liable for any consequences.
