आदरणीय महोदय,


आपको अवगत कराना है कि डॉ. भीमराव अम्बेडकर विधि विश्वविद्यालय, जयपुर ने बहुत सीमित समय में विधिवत संचालन शुरू कर दिया है। बोर्ड ऑफ मैनेजमेंट की तीन बैठकें तथा उनमें महत्वपूर्ण निर्णय, एल.एल.एम में प्रवेश तथा शिक्षण कार्य का प्रारम्भ, समस्त 88 विधि महाविद्यालयों की सम्बद्धता की प्रक्रिया हेतु आवश्यक निर्णय, छात्र हितों को ध्यान में रखते हुये इन सभी महाविद्यालयों में पढ़ाये जाने वाले विधि शिक्षा के भिन्न-भिन्न पाठ्यक्रमों हेतु समान पाठ्यक्रम तैयार कर लागू किया जाना ताकि वर्ष 2020-21 में सभी छात्रों की परीक्षाएँ व्यवस्थित ढंग से आयोजित कर समय पर परीक्षा परिणाम घोषित किये जा सकें इत्यादि।

महोदय, इसी प्रक्रिया में आपको यह भी अवगत कराना है कि विश्वविद्यालय के अस्तित्व में आ जाने के तुरन्त बाद दिनांक 06 मार्च, 2020 को मेरे द्वारा व्यक्तिगत रूप से पत्र के माध्यम से बार काउंसिल के अध्यक्ष को विश्वविद्यालय की स्थापना के बारे में अवगत कराया गया (सलंगनक-1), तत्पश्चात, राज्य सरकार द्वारा जारी आदेश दिनांक 22 जुलाई, 2020 जिसके द्वारा प्रदेश के सभी विधि महाविद्यालयों को डॉ. भीमराव अम्बेडकर विधि विश्वविद्यालय के साथ सत्र 2020-21 से ही सम्बद्ध होना है, के बारे में भी दिनांक 27 जुलाई, 2020 को बार काउंसिल ऑफ इण्डिया को अवगत करा दिया गया (सलंगनक-2), तथा बार काउंसिल ऑफ इण्डिया द्वारा विश्वविद्यालय की विधिवत मान्यता/सम्बद्धता हेतु दिनांक 30 मार्च, 2021 को आवश्यक फीस रूपये 5,50,000/- के साथ निर्धारित प्रोफोर्मा पर तीन प्रतियों में आवेदन भी प्रस्तुत कर दिया गया है (सलंगनक-3)।

महोदय, विश्वविद्यालय द्वारा प्रत्येक स्तर पर नियमानुसार आवश्यक कार्यवाही की जा रही है तथा विश्वविद्यालय प्रशासन विश्वविद्यालय में शिक्षा के उच्च मानदण्डों को स्थापित करने हेतु प्रतिबद्ध है।



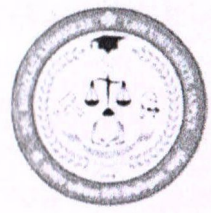

Dear Sir,

Dr. Bhimrao Ambedkar Law University is a State funded University established by an Act No. 6 of 2019 of State Government of Rajasthan. The University has come into being and as its endeavour has started extending affiliation to all the Law Colleges of the State, running UG and PG Programmes in Law with due approval of BCI from session 2020-21. Besides this, the University has commenced the Academic Session 2020-21 with LL.M. one year programme as its residential academic activity with intake of 40 students. The Bar Council of India (BCI) was duly informed about the establishment of the University and its jurisdiction vide letter dated 06th March, 2020 and 27th July, 2020. (Copies enclosed). The University will undertake the Five years integrated Law programme (undergraduate) as its residential academic activity in due course, when fully prepared.

The University is currently operating from its office at RUSA Building, Shiksha Sankul, Jaipur and the State Government will allot the land for its permanent campus very soon. Also the State Government has sanctioned 48 Non-teaching posts and 35 teaching posts (5 Professors, 10 Associate Professors, 20 Assistant Professors) for the University. The process of deployment of the said positions is underway.

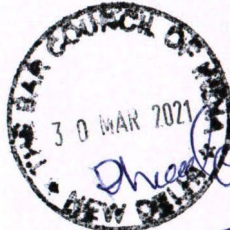
It is also pertinent to mention here that in the year 2012 the University with the similar name was established, which could not be made functional and the same was repealed and abandoned in 2015 by State Government of Rajasthan.

The application in triplicate along with all necessary documents and details of the fee paid i.e Rupees Five Lac for guarantee and Rupees Fifty Thousand for application is enclosed for necessary processing at your end for Recognition of the University by Bar Council of India.

Awaiting an early response at your end.
